Surcharge	Description	Fee
Address Change - Air Service	Any time after the order is placed that a request is made to change the pickup or delivery address for a shipment going by air.	\$13.75
Address Change - Ground/Ocean Service	Any time after the order is placed that a request is made to change the pickup or delivery address for a shipment going by ground or ocean.	\$11.25
Attempt Fee	An attempt to pickup or deliver may be charged at an additional base rate, plus fuel surcharge.	Variable
COD Fee	A dollar amount specified on the C.O.D. tag or package label to be Collected On Delivery. WPX accepts business or personal checks, cashier's checks or money orders. <b>No Currency in any amount will be accepted.</b>	\$15.00
Credit Card Processing Fee	All payments made with a credit card, debit card or purchase card will be assessed a processing fee.	3.5%
Declared Value	For shipments valued in excess of \$100 the fee is \$0.95 per \$100. Maximum \$5,000.	\$0.95 /\$100
Geographical Adjustment - B City Charge	Geographical adjustment for a pickup or delivery to a B rated city zone.	\$17.00
Geographical Adjustment - C City Charge	Geographical adjustment for a pickup or delivery to a C rated city zone.	\$27.00
Geographical Adjustment - Other Outlying City Charge	Geographical adjustment for a pickup or delivery to a city in an outlying area, not B or C zoned, other charges may apply.	\$52.00
Drop Ship Surcharge	Handling charge when another carrier delivers a shipment to a WPX facility to then be forwarded by WPX to another location.	\$15.00
Fuel Surcharge	Fuel Surcharge is calculated monthly using the previous month's average weekly retail Gasoline and Diesel prices reported by the U.S. Energy Information Administration's website, <a href="http://www.eia.gov">www.eia.gov</a> . \$5.00 Minimum on all GoldStreak and Air Freight Shipments.	Variable
Hazardous Materials - Air Service	<b>Preapproved Customers Only.</b> Consumer Commodity and Limited Quantity. The customer is responsible for proper classification, packaging, marking and hazardous shipping papers.	\$79.75
Hazardous Materials - Ground Service	<b>Preapproved Customers Only.</b> Consumer Commodity and Limited Quantity. The customer is responsible for proper classification, packaging, marking and hazardous shipping papers.	\$30.00
Hazardous Materials - Ocean Service	<b>Preapproved Customers Only.</b> Consumer Commodity and Limited Quantity. The customer is responsible for proper classification, packaging, marking and hazardous shipping papers.	\$95.00

Military Base Surcharge	Additional charge for accessing a Military Base for pickup or delivery.	\$38.00
Pickup Charge - Air Freight Service	Charge for pickup of shipment at customer's location, moving by an Air Freight service.	\$81.00
Residential Surcharge - Air or Ground Service	Additional charge for pickup or delivery to or from a residential address.	\$5.25
Residential Surcharge - Ocean Service	Additional charge for pickup or delivery to or from a residential address.	\$22.00
Sales Tax - Kenai Peninsula Borough Alaska	Effective 1/1/2017 applies to all Ground transportation services originating on the Kenai Peninsula and delivered in Alaska.	Variable
Special Handling Surcharge	An additional handling charge may be assessed for any package that requires special handling, as determined by WPX in its sole discretion.	\$27.50
Saturday Surcharge - Air or Ground Service	Charge for pickup or delivery of an Air or Ground shipment on a Saturday.	\$38.00
Saturday Surcharge - Air Freight Service	Additional charge for a pickup or delivery of an Air Freight shipment on a Saturday.	\$52.00
TSA Security & Screening Fee - Air Overnight Letter (up to 1 lb.)	Charge implemented by the Transportation Security Administration to help finance the increased cost of securing the nation's transportation systems.	\$1.09
TSA Security & Screening Fee - Air Express or 2Day Air	Charge implemented by the Transportation Security Administration to help finance the increased cost of securing the nation's transportation systems.	\$2.41
TSA Security & Screening Fee - Air Freight	Charge implemented by the Transportation Security Administration to help finance the increased cost of securing the nation's transportation systems.	\$7.98
TSA Security Fee - Ocean Service	Charge implemented by the Transportation Security Administration to help finance the increased cost of securing the nation's transportation systems.	\$2.15
Waybill / Manual Entry Charge	When a manual waybill is used for shipment instead of the customer placing the order online through the WPX website.	\$4.75
